Supervisor Davidson stated that the Town would need to come up with a way to find the money because we cannot go to the taxpayers for it. The upstairs is getting dangerous and that safety and security is the main concern.

Councilman Haviland made motion, seconded by Coucilman Van Cleef to set up a three member committee, one from the Fire Department, Library and the Town Hall to discuss the plans of the new structure of the Town Hall. Lou Van Cleef will be for the Town Hall, Councilwoman Jones will be for the Library and Councilman Haviland will have to ask someone from the Fire Department to sit on the committee. Councilpersons Haviland, Jones, and Van Cleef voting Aye.

Supervisor Davidson mentioned that an Open House will be held December 3, 2011 at the Town Hall from 3pm to 6 pm. An ad will be put in the Area Wise Shopper.

Councilwoman Jones made motion, seconded by Councilman Haviland, to adjourn the meeting at 8:15p.m. So carried with Councilpersons Haviland, Jones, and Van Cleef voting Aye.
